Application & Rates

- General rate: ½ oz. per gallon or 0.4% in metered systems.
- As a foliar spray – use a 1% - 1.5% solution of Repel to wet foliage thoroughly. Repeat every 30 days or as necessary.
- As a soil drench – use a 2% solution to wet entire field – and a margin surrounding the entire area -1 week preplanting.
- In an ultra-low volume (ULV) fogger – mist a 1% solution outdoors covering as much area as possible from ground level to as high as you can reach – especially near brush of heavy vegetation.
- **DO NOT USE REPEL IN ANY THERMAL FOGGERS, OR HEAT IN ANY WAY BEFORE USE.**
- As a perimeter spray on concrete, brick, wood, or any other non-living material – spray a 5% solution entirely around the structure or area – **DO NOT SPRAY THIS STRENGTH ON LIVING PLANT TISSUE.**

Storage, Handling and Usage

- **Shake or agitate product before use.**
- Fill daytank with amount of water for dilution first, then add measured amount of Repel 420.
- Store out of sunlight in a cool dry area. Do not freeze.
- Close container securely after each use.
- Do not store diluted product. Apply all diluted product within 24 hours.
- Consult your GGOIM representative before mixing Repel 420 with any other product.
